

The **Coronavirus CivActs Campaign (CCC)** gathers rumours, concerns and questions from communities across Nepal to eliminate information gaps between the government, media, NGOs and citizens. By providing the public with facts, the CCC ensures a better understanding of needs regarding the coronavirus and debunks rumours before they can do more harm.

Rumors & Facts



Although the government has claimed to make the system easy for the farmers, the situation remains the same. Whom should they contact in case they need support?

When the results of COVID-19 tests in other parts of Nepal are positive, it is further sent to Kathmandu for a re-test. Are the patients kept in quarantine until the results of the re-tests from Kathmandu arrive?

The cross-verification of the tests from different parts of the country is conducted in the National Public Health Laboratory, B.P Koirala Institute of Health Sciences, and Bheri Hospital. The patients should be kept in isolation, and their management should be the same as the COVID-19 positive patients.



Although the government has declared that they will give a pass for people to go to the hospital when sick, it is not helpful for people like us, who do not have vehicles.

The kidney patients who regularly have to conduct dialysis, the cancer patients who have to undergo chemotherapy, and the patients with long term illness can dial in 1180 for a free of cost ambulance for the two-way trip from their home to the hospital arranged by the Kathmandu Metropolitan City. 

The embassy has directed all the workers from Nepal to consult their problems with the hotel management and take all the precautionary measures for their safety.



Data from Nepal police (24th March - 13th April)



According to Nepal Police, criminal activities have reduced by upto 90% after the lockdown began on March 24th, 2020. However, data of the first three weeks of lockdown shows that rape and domestic violence are still prevalent across the country. Women and girls are unsafe in their own communities and family. We need a responsive local government and an easy reporting mechanism to fight rape and domestic violence.



Where can I get a coronavirus test?

The PCR tests for Coronavirus are conducted in 14 Labs across 7 provinces including the National Public Health Laboratory whereas R.D.T tests are conducted in all 7 districts across Nepal.

Is the sick person allowed to go to the lab to get tested? How much does it cost?

The sick person is not allowed to go to the lab directly. The local hospitals will refer to the NPHL to test if suspected. There is no cost for the test.

How long does it take to see the results of the test?

The PCR tests reports are given in between 6 to 48 hours, whereas the reports for RDT tests are given in 15 minutes.

The sources of rumors, information and issues presented here are collected from a variety of organizations and individuals including the Ministry of Health and Population, the World Health Organization (WHO), social media and the CivActs team based on their conversations with over 2000 people in April 2020. The issues highlighted are chosen based on prevalence, relevance and potential impact. The information presented here is correct at the time of issue.
