


UMkhankaso Wezinhlangano Zomphakathi Maqondana Negciwane iKhorona unqanda amahlebezi nemibono evela emiphakathini ukuze kuvalwe igebe lokutholakala kolwazi phakathi kukahulumeni, abezindaba, amaNGO, abezamabhizinisi kanye nomphakathi. UKUXOXISANA NGOHLELO LWENKOKHELO YE-UIF

Izinkampani eziningi zibhekana nezinkinga zokuthola izinkokhelo ezikhethekile zeCOVID-19 UIF ezikhona zezisebenzi zazo. Ezinye zezinkinga ezikhona ngezokuthi yizisebenzi ezithile ezingakazitholi lezi zinkokhelo, kanye nokuthi izisebenzi zokufika azikhokhelwa. Izisebenzi ezinikezwe izinhlabakhefu, eziphunyuziwe okwesikhashana, noma lezo abaqashi bazo abangakwazi ukukhokhela amaholo azo agcwele kufanele zikhokhelwe ngenkokhelo ekhethekile evela kwi-UIF, ebizwa ngeCOVID-19 Temporary Relief (i-TERS). Imali enkulu ezotholwa yisisebebenzi ngu-R6,730 ngenyanga (uma sihola ngaphezulu kuka-R17, 700) - bese kuthi encane kube ngu-R3,500. Imali eyisilinganiso esiphakathi nendawo ekhokhwayo ngu-R5,000. Embikweni wanamhlanje, sibuka ukuthi yimiphi imigomo ebekiwe ukwenza uhlelo lokukhokhelwa lube ngcono.



Kusukela ekuqaleni kwaleli sonto, i-UIF ikhokhe cishe izigididi ezingu-R9.5 emhlomulweni okhethekile weCOVID-19- okumele utholwe yizisebenzi eziyisigidi esingu-1.9. Isamba esiyizigididi ezingu-R2,2 kusalindwe ukuthi sikhokhelwe izisebenzi njengoba lesi sikhwama sisadingida imibuzo yabadinga usizo.
